



Symposium DB PERKS Raffle – Rules, Terms and Conditions

The “Symposium DB PERKS” Raffle is being conducted by BC Recreation and Parks Association (BCRPA), a not-for-profit, charitable organization under the laws of the Province of British Columbia.

Ticket purchaser must be 19 years of age or older to participate and must be a **paid delegate** of BCRPA 2019 Symposium.

There is no limit to the number of tickets one (1) person may purchase.

The winner must agree to allow BCRPA to publicize their part in the raffle outcome, including approval for their photograph, name, and city of residence being disclosed.

The term of the promotion is from May 1 – May 3, 2019; during this time, tickets may be purchased onsite at the Symposium registration desk during conference hours.

Raffle tickets are 2 tickets for \$5.00, or 5 tickets for \$10.00 payable by cash or by credit card.

Exclusions

Excluded from the raffle are: BCRPA Board and staff members, their partners and families; volunteers, their partners and families; Symposium exhibitors and sponsors, their partners and families; presenters who are not paid delegates.

Exempt from exclusion are **exhibitors and sponsors who purchased delegate upgrades.**

Prize: One prize will be given away, consisting of:

- A two bedroom suite furnished with one king and two twin beds, and a fold out couch in living room
- Master bedroom features a king bed and ensuite bathroom, including a soaker tub with jacuzzi jets, separate shower, and flat screen TV
- Second bedroom features 2 twin beds with a flat screen TV and access to the second bedroom
- Suite includes a full kitchen and dining area equipped with a fridge, stove, dishwasher, and microwave
- Living room area includes a flat screen television, gas fireplace, and walk-out patio
- Total suite size: approximately 1,028 sq. ft
