Notes: * Adults supervising child/youth recreation programs need not be in the space at all times, only that there is some form of supervision (ie. it is not an informal gathering of children or youth). Those supervising child/youth programs may be under 22yrs (need not be adults).
Definition, Adult Sport: organized individual or group sport activities that take place in an indoor setting for those aged 22 and older (e.g. but are not limited to league soccer, swim clubs, drop-in hockey, pairs badminton).
Outdoor Activities & Sport: Proof of vaccination is not required for participants or spectators, except in Interior Health where spectators over 100 and all adult participants require 2-dose PoV.
